# COVID-19 PANDEMIC PARTICIPANT CONSENT FORM

## Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, the Ministry of Health and Wellness recommends mask wearing, sanitization and social distancing and have prohibited the congregation of groups of people.

Total Time/Event Organizers have put in place preventative measures to reduce the spread of COVID-19; however, Total Time cannot guarantee that you or your child(ren) will not become infected with COVID-19. Further, attending this event could increase your risk and your child(ren)'s risk of contracting COVID-19.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance at these events.
